- ⇒ The study has been published and some copies will be distributed during the IAC 2022 in Paris
- Study Group 5.16 Chair: Prof. Liu Jizhong Study on International Policy and Legal Regimes for Space Natural Resources Exploitation and Utilization (SREU)
   ⇒ A draft is available. The study has been organized and started the review process. The Group is looking for new members

- Study Group 5.17 Chairs: Bonnal/McKnight Space Debris Situation Report
- ⇒ No progress. However, the Chair is thinking about a periodic update
- Study Group 5.18 Chairs: Denis / Jorgenson Space and disasters management: new systems, new usages and opportunities for international cooperation
- ⇒ The study is in standby since 2 years. However, the study objectives are still fully relevant. The study established a new roadmap. It will be submitted to the Group in November for a common decision to how proceed

- Ecotax to fund space debris removal: D Alary
- The text is ready. The study needs a template and a general communication
- Investigate a Transdisciplinary Approach to Protect the Dark and Quiet Sky from Satellite Constellation Interference: Moriba Jah
- The study will review the views of government and private actors toward Extended Producer Responsibility (EPR) to understand the effects and impacts of satellites on dark and quiet skies for astronomers, planetary defense and Near Earth Object (NEO)
