Study Group 5.12 - Dynamics of Space Exploration Strategies and Future Outlook

Serge Plattard informed that the study was stopped. A new study will be proposed at the Spring meeting 2020 by Nicolas Peter.

Study Group 5.16 - International Legal and Policy Regimes for Space Natural Resources Exploitation and Utilization (SREU)

Wang Guoyu (on behalf of CNSA) introduced the study project, explained the perspectives and the approach. The Group is formed by Chinese members and some international members. There is the need to find additional members, in particular for policy matters. It will take in consideration the past studies and the work of external Working Group. The first internal draft is progressing and a draft report is expected for September 2020.
